TROSS, INC., a Florida corporation, hereby certifies:

The sole member of the Board of Directors and the sole Stockholder of the Corporation at a meeting duly called and held on April 24, 2002, adopted the following Resolution:

WHEREAS, it is deemed to be in the best interest of the Corporation that Article II of the Articles of Incorporation be amended as hereinafter set forth:

NOW, THEREFORE, BE IT RESOLVED that the Articles of Incorporation of TROSS, INC. be amended, changed, and altered as follows:

The following provision is added to this Article II:

ARTICLE II PURPOSES

Upon the closing on or about April 30, 2002 of take-out first mortgage financing to be provided by Royal Indemnity Company, which financing replaces the financing referenced in the Operative Agreements, the term "Operative Agreements" as used herein shall mean and refer to the Project Loan Agreement by and between this Corporation as Borrower and Royal Indemnity Company as Lender dated on or about April 30, 2002.

BE IT FURTHER RESOLVED, that the President direct Counsel for the Corporation to prepare the necessary Articles of Amendment for signature by the Corporation, through its proper officers, to legally affect the Amendment to the Articles
