The undersigned, acting as director(s) for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopt(s) the following Articles of Incorporation. EFFECTIVE DATE

#### ARTICLE I

The name of the corporation shall be Southwest Interim Bank No. 3 and its initial place of business shall be 3700 South Tamiami Trail, in the City of Sarasota, in the County of Sarasota, and the State of Florida.
