**CERTIFICATE OF CHARTER CANCELLATION**


WHEREAS, West Coast Bank, Sarasota, Florida, was authorized by the State of Florida to commence a general banking business on April 15, 1988, under Charter No. 963. West Coast Bank then merged with and into Southwest Interim Bank No. 3, with resulting title of West Coast Bank, and was assigned new Charter No. 1043, effective January 12, 1998; and

WHEREAS, EFFECTIVE January 1, 1999, West Coast Bank, merged with and into West Coast Guaranty Bank, N.A., Sarasota, Florida, under the charter and title of West Coast Guaranty Bank, N.A., Sarasota, Florida; and

WHEREAS, West Coast Bank, was asked to return Certificate of Authority No. 1043 for cancellation and neither the original nor any copy of the Certificate can be located;
