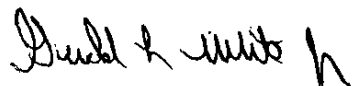
This is in response to the second notice pertaining to the corporation filing. The first notice was never received and I would appreciate if the filing fee could be waived since the first notification was not received.
