ARTICLES OF INCORPORATION  
OF  
SOUTHEAST CHECK CASHING, INC.

The undersigned Incorporator, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME

The name of the Corporation is Southeast Check Cashing, Inc.

ARTICLE TWO

PRINCIPAL OFFICE AND ADDRESS

The address of the principal office of the Corporation is 4070 Vallie Road, Marianna, Florida 32446, and the mailing address of the Corporation is 4070 Vallie Road, Marianna, Florida 32446.

ARTICLE THREE

SHARES, CLASS AND PAR VALUE

The Corporation is authorized to issue one class of shares, which shall be called common shares. ARTICLE SEVEN


