#### **ARTICLE TEN: CONTRACTS WITH OTHER CORPORATIONS**



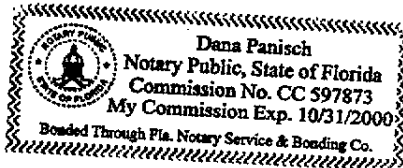


