ARTICLE I--NAME

The name of this corporation is ERIC E STRAMMER, PA.

ARTICLE II--DURATION

The power to adopt, amend or repeal by-laws of this corporation shall be vested in the members.


ARTICLE XI--INDEMNIFICATION


