The number of votes cast by written consent for dissolution was unanimous, and thus was sufficient for approval.


ARTICLE IV: EFFECTIVE DATE OF DISSOLUTION


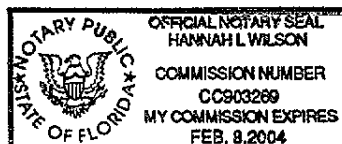
