ARTICLE I. NAME

The name of this corporation is KLEGER, INC.





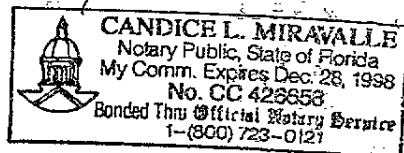
