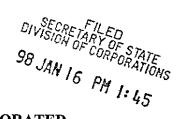

#### <u>ARTICLE I - NAME</u>

The corporation shall indemnify any officer or director or any former officer or director to the full extent permitted by law.

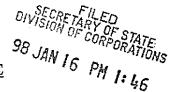
## ARTICLE XI - AMENDMENT
