## ARTICLES OF AMENDMENT OF WILD BIRDS UNLIMITED OF PINELLAS COUNTY, INC.

THE UNDERSIGNED, WILLIAM K. LOVELACE, being the Vice President and Assistant Secretary, of WILD BIRDS UNLIMITED OF PINELLAS COUNTY, INC., does hereby certify that the following Amendment to the Articles of Incorporation of WILD BIRDS UNLIMITED OF PINELLAS COUNTY, INC. was approved by the Stockholders of said Corporation on the 10th day of February, 1998, at a duly called meeting of the Stockholders and Directors of the Corporation.

The Articles of Incorporation of WILD BIRDS UNLIMITED OF PINELLAS COUNTY, INC. are hereby amended as follows:

1. Article I is hereby deleted and the following is inserted in lieu thereof:

### ARTICLE I - NAME

The name of the Corporation shall be SFRAGA ENTERPRISES, INC.

2. Article II is hereby deleted and the following is inserted in lieu therof:

#### ARTICLE II - NATURE OF BUSINESS

The corporate purpose is limited to the operation of one or more Wild Birds Unlimited, Inc. franchises.

The transfer or issuance of any stock of the corporation or the sale or transfer of any interest in the franchise is restricted by the terms of the Franchise Agreement between the franchisee and Wild Birds Unlimited, Inc.

- 3. All amendments included herein were adopted pursuant to Section 607.1006, F.S., and there is no discrepancy between the Corporation's Articles of Incorporation as theretofore amended other than the inclusion of these amendments and the omission of matters of historical interest.
- 4. This Amendment has been approved by unanimous consent of all of the Shareholders of the Corporation who are entitled to vote.
- 5. This Amendment shall be effective upon its filing with the Secretary of State, State of Florida.
