#### ARTICLES OF INCORPORATION

FEMI SOMORIN, a natural person competent to contract does hereby subscribe, acknowledge and file in the offices of the Secretary of the State of Florida for the purpose of forming a corporation for profit in accordance with the laws of the State of Florida, these Articles of Incorporation as by law provided.

## ARTICLE I

NAME

The name of this corporation shall be as stated above.

# ARTICLE II

# GENERAL NATURE OF BUSINESS

This Corporation may engage in any activity or business permitted under the laws of the United States of America and the State of Florida, including but not limited to IMPORT/EXPORT OF MERCHANDISE.

# ARTICLE III

## CAPITAL STOCK

The maximum capital stock authorized to be issued by this Corporation shall be FIVE HUNDRED (500) SHARES having a par value of ONE (1) DOLLAR per share. Each of said shares of stock shall entitle the holder thereof to ONE (1) vote at any meeting of the stockholders. All or any part of said stock may be paid in cash, in property (other than stock or Securities), or in labor services at a fair valuation to be fixed by the Incorporators, or by the Board of Directors, at a meeting called for such purpose. All stock when issued shall be fully paid for and shall be nonassessable.

## ARTICLE IV

#### INITIAL CAPITAL

The stock of this Corporation shall be issued persuant to a plan under Section 1244 of the Internal Revenue Code of 1954 as added by the Small Business Tax Revision Act of 1958. The amount of capital with which this Corporation shall begin business shall be no less than FIVE HUNDRED (500) DOLLARS.

#### ARTICLE V

# TERMS OF EXISTENCE

This Corporation shall have perpetual existence.

#### ARTICLE VI

## PRINCIPAL OFFICE

The following shall be the street address and the principal registered office of this Corporation, but the Corporation shall have the power to move the principal office to any other address in the state of Florida and to establish branch offices and other places of business at any such other places within or without the State of Florida that may be deemed expedient. ## ARTICLE VII

## DIRECTORS

There shall be a Board of Directors for this Corporation which shall consist of not less than ONE (1) and not more than THREE (3) the number of same to be fixed by the Corporate By-Laws. Each of said Directors shall be of full age and at least one of them shall be a citizen of the United States. Any ONE (1) Director may be removed, without cause, at any annual or special meeting of the Stockholders, where a quorum is present in person or by proxy, by the affirmative vote of a majority of the outstanding stockholders of the Corporation who are entitled to vote at said meeting of the Board of Directors, where a quorum is present in person or by proxy by the affirmative vote of a majority of the Directors present at said meetings.

## ARTICLE X

# CONFLICT OF INTEREST

No contract or other transaction between this Corporation and any other corporation, and no act of this Corporation shall in any way be afflicted or invalidated by the fact that any of the officers of this Corporation are pecuniarily or otherwise interested in are directors or officers of such other corporation provided that any director individually or any firm of which any director may be a member, may be a party to, may be pecuniarily or or otherwise interested in any contract or transaction of this Corporation, provided that the fact he or such firm so interested shall be disclosed or shall have been known to the Board of Directors or a majority thereof, any Director this Corporation who also is a director or officer of such other corporation who is so interested may be counted in determining the existence of a quorum at any meeting of the Board of Directors of this Corporation which shall authorize such contract or transaction with like force and effect as if he were not such director or officer or such other corporation or not so interested.

#### ARTICLE XI

#### INDENMIFICATION

Every director and every officer of the Corporation shall be indemnified by this Corporation against expenses and liabilities including counsel fees, reasonably incurred by or imposed upon him in connection with any proceedings to which he may be a party to or which he may be involved, or any appeal therein, by reason of his being or having been a director or officer of this Corporation.
