



ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation, a natural person(s) competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I.

NAME

The name of this corporation shall be Punky Charters, Inc. and the address of this corporation is 2563 Conch Cove Lane, Palm City, Florida 34990.

ARTICLE II.

DURATION

This corporation shall have perpetual existence.

ARTICLE III.

PURPOSE


