

ARTICLE NINE. AMENDMENT



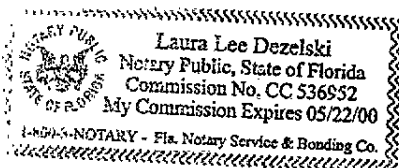
