In compliance with the requirements of F.S. Chapters 607 and 621, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation (the "Corporation") shall be:

RUYE H. HAWKINS, P.A.

ARTICLE II

The purpose for which this Corporation is organized is to provide legal services to the general public.

ARTICLE III

This Corporation shall exist perpetually unless dissolved according to law.

ARTICLE IV

The street address of the principal office of the Corporation shall be:

ARTICLE V

The maximum number of shares this Corporation is authorized to issue is 1000, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which Shareholders have the right to vote.




