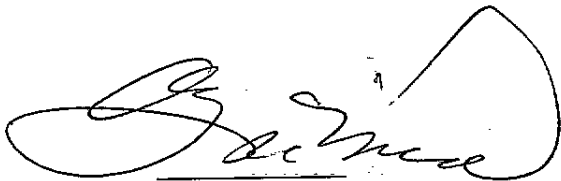
ARTICLE IX - INDEMNIFICATION

ARTICLE X - AMENDMENT

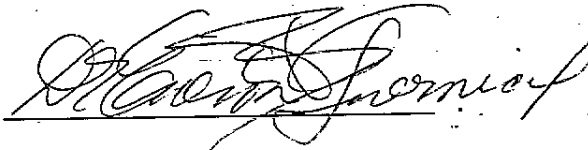
