ARTICLES OF AMENDMENT
OF
SUMMIT HEALTH VENTURES, INC.

PURSUANT TO SECTION 607.1006 OF THE FLORIDA BUSINESS CORPORATION ACT, THE UNDERSIGNED CORPORATION ADOPTS THESE ARTICLES OF AMENDMENT.

FIRST: THE NAME OF THE CORPORATION IS SUMMIT HEALTH VENTURES, INC.

SECOND: THE ARTICLES OF INCORPORATION OF THIS CORPORATION ARE AMENDED BY CHANGING THE ARTICLES NUMBERED I AND V SO THAT, AS AMENDED, SAID ARTICLES SHALL READ AS FOLLOWS:

ARTICLE I: The name of the corporation is West Palm Beach Technologies, Inc.

ARTICLE V: The maximum number of shares of stock which the Corporation is authorized to issue is 50,000,000 shares of common stock having a par value of \$.01 per share.
