ARTICLES OF INCORPORATION
OF
SECRETARY OF STATE
JOHN E. LARSEN RESIDENTIAL CONTRACTOR, INTALLAHASSEE, FLORIDA

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be John E. Larsen Residential Contractor, Inc. hereinafter referred to as the "corporation".

This corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

This corporation shall have all such powers as may be permissible to corporations under the laws of the State of Florida, and all powers necessary or desirable to accomplish the purposes and business of the corporation as hereinabove set forth in Article II.

This corporation has the authority to issue one thousand shares of common stock with a par value of one Dollars (\$1.00) per share.

This corporation is to exist perpetually.

The initial street address of the principal office of this corporation in the State of Florida is: 1356 34th Avenue, Vero Beach, FL 32960. The Board of Directors may from time to time move the principal office to any other address in Florida.

This corporation shall have one (1) director initially. The number of directors may be increased or diminished from time to time, as provided in the By-Laws.

ARTICLE VIII

This director shall hold office until the first annual meeting or until her successors are elected or appointed and qualified as provided in the By-Laws.

ARTICLE IX

ARTICLE X
Unless otherwise provided in the By-Laws, every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others. The By-Laws may provided that every stockholder is not to have the right to so purchase. The By-Laws may provide for cumulative voting for directors and may make provisions governing the issuance of stock certificates to replace lost or destroyed certificates. These directors shall be elected by the shareholder at each annual meeting and the officers shall be elected by the director at each annual meeting. the director at each annual meeting. The date of the annual meeting shall be fixed by the By-Laws.

ARTICLE XI

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the stockholders, and approved at a stockholders' meeting by the majority of the stock entitled to vote thereon, unless all of the directors and all of the stockholders sign a written statement manifesting their intentions that a certain amendment of these Articles of Incorporation may be made.

ARTICLE XII The registered agent for service of process within this state shall be John E. Larsen of 1356 34th Avenue, Vero Beach, FL 32960.


