ARTICLES OF INCORPORATION

OF

WENDY I. RULNICK, P.A.

ARTICLE I - NAME:

The name of this Professional Service Corporation WENDY I. RULNICK, P.A., hereinafter referred to as the "Corporation")

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.
