ARTICLES OF INCORPORATION
OF

ARTICLE I

Name of Corporation

The name of this corporation is Social Services Unlimited, Inc.

The address of the principal office of this corporation shall be 5948 Doraville Drive, Port Orange, Florida 32127.

ARTICLE II

Nature of Business

This corporation may engage or transact in any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, country, territory or nation.

ARTICLE III

Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 50 shares of common stock having no par value per share.

ARTICLE IV




Amendment of Articles
