The undersigned, for the purposes of forming a corporation for profit under the laws of the State of Florida, does hereby form a corporation and adopt the following Articles of Incorporation:

ARTICLE I

VIDS PHOTOGRAPHY, Inc.

1.1 The name of the corporation shall be VIDS PHOTOGRAPHY, Inc.

ARTICLE II

Purpose

2.1 The corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE III

Duration

3.1 The period of duration of corporate existence shall be perpetual.

ARTICLE IV

Capital Stock

4.1 The corporation is authorized to issue 100 shares of \$1.00 per value stock of only one class: common stock.

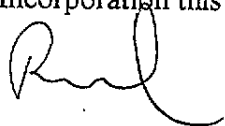

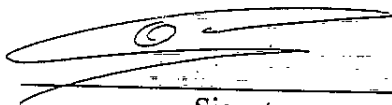
