**ARTICLES OF INCORPORATION
Of

In compliance with the requirements of F. S. Chapter 607, the undersigned, being a natural person, does hereby act as the incorporator in adopting and filing these articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

EFFECTIVE DATE
01-13-98

The name of the corporation is CONTINENTAL CONNECTIONS, INC.

ARTICLE II

The existence of the corporation shall begin January 13, 1998, and be perpetual.

ARTICLE III
