## ARTICLES OF INCORPORATION

#### OF

# DRL ENTERPRISES, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

### ARTICLE ONE:

The name of the corporation is DRL ENTERPRISES, INC.

### **ARTICLE TWO:**

The duration of the corporation is perpetual, with commencement at the time of filing these Articles.

### ARTICLE THREE:

The general purposes for which the corporation is organized are:

- 1. The number of directors constituting the initial board of directors of the corporation is two (2). The name and address of the persons who are to serve as members of the initial board are:


