- 3. The Info Only (Statement of Fact), dated 10/8/2019; Document #P98000005858, was filed by an heir of the estate asset who had misunderstandings about the probate estate asset which have now been resolved and contains incorrect information.
- 4. The Court finds that because the above, 3 documents contain either fraudulent or incorrect information and are therefore invalid.
- 5. The Division of Corporations has agreed that upon entry of this Order, it will annotate such records accordingly and post a copy of this Order.
