ARTICLE I. NAME

The name of this corporation shall be AUM NAMAH SHIVAYA, INC.

ARTICLE II. PRINCIPAL OFFICE

The mailing address and principal place of business of the corporation is 4410 14th Street West, Bradenton, Florida 34207.

ARTICLE III. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of signing of these Articles Of Incorporation. This corporation's duration shall be perpetual.
