ARTICLES OF INCORPORATION

OF

NATURE'S NURSERY, INC.

ARTICLE I. NAME

The name of this corporation is NATURE'S NURSERY, INC.

ARTICLE II. DURATION

This corporation shall exist perpetually.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of marketing clothing, books, herbs and other infant care items and for all other lawful purposes.
