ARTICLE I

Name and Duration

The name of the Corporation is JOHN FRANCIS O'BRIEN, M.D., P.A. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State.

ARTICLE II

Principal Office

ARTICLE III

Registered Office and Agent

Corporate Purposes, Powers and Rights

ARTICLE XI

Transfer of Shares

If, from time to time, a shareholders' agreement among all of the shareholders of the Corporation is in effect, then transfers of the Corporation's Common Stock made, not in accordance with such agreement, whether by operation of law or otherwise, are null and void <u>ab initio</u>.
