**ARTICLES OF INCORPORATION

The undersigned Incorporator, for the purpose of forming a corporation under the laws of the State of Florida, adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be J and Azuree Corporation

ARTICLE II

Nature of the Business:

The general nature of the business shall be to operate a pizza parlor/restaurant with sales of related products and services. In addition to do any and all activities or business permitted under the laws of the United States and of this State, as fully and to the same extent as natural persons might or could.

ARTICLE III

Capital Stock:

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is seventy-five hundred (7,500) shares of common stock having no par value.

ARTICLE IV

Existence of the Corporation:
