ARTICLES OF INCORPORATION OF EXCELSIOR INVESTMENTS, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adapt the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be:
