ARTICLES OF INCORPORATION

OF

GRAND VINTAGE, INC.

The undersigned, acting as the sole Incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

ARTICLE I

NAME AND ADDRESS

The name of the Corporation is Grand Vintage, Inc. The address of the Corporation is 1364 Cypress Woods Drive, Naples, Florida 34103.
