ARTICLES OF INCORPORATION

FOR

SA JAN 20 PM 2: 3 General The undersigned, for the purpose of forming a corporation unders Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is SUN IRRIGATION, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purposes for which the corporation is organized are:

- To engage in the installation and maintenance/repair of irrigation systems, and to 1. transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
- To do such other things as are incidental to the foregoing or necessary or desirable in 2. order to accomplish the foregoing.
