ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of the captioned corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

Corporate Name and Principal Office

The name of this corporation is DALEN'SEL INVESTMENTS, INC. and its principal office and mailing address is 10006 N. Dale Mabry Highway, Suite 210, Tampa, Florida 33618.

ARTICLE II

Commencement of Corporate Existence

The corporation shall come into existence on January 15, 1998.

General Nature of Business
