OF JAMES G. COLLIER, INC.

ARTICLE I - NAME

The name of this corporation is James G. Collier, Inc..

ARTICLE II - TERM OF EXISTENCE

The corporate existence shall commence at the time of signing and acknowledging these Articles of Incorporation. The corporation shall have perpetual existence, except that the same may be dissolved, as provided by law.

ARTICLE III - PURPOSE

The corporation may engage in any activity or business permitted under the Laws of the State of Florida.
