ARTICLES OF INCORPORATION

OF

J. GROUND ZERO PRODUCTIONS, INC.

So Marion Control The undersigned subscriber to these Articles of Incorporation is a nat person competent to contract and hereby form a corporation under the laws of the State of Florida.

<u>ARTICLE I - NAME</u>

The name of the corporation is J. GROUND ZERO PRODUCTIONS, INC.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

- To engage in any activity or business permitted under the laws of (a) the State of Florida and the United States of America; and,
