Dear Sir or Madam:

Pursuant to my conversation with your office today, enclosed please find a check in the amount of \$150.00 which represents the annual fee for the above referenced corporation. It is my understanding that this corporation has been administratively dissolved due to its failure to file an annual report. I was informed that two notices from your office were sent to this corporation to advise that an annual report was due to be filed. However, this corporation never received said notices as evidenced by the attached affidavits.

It must be stated that at all material times this corporation had every intention of being in complete and full compliance with all appropriate administrative rules and Florida Statutes. However, it was under the belief that its annual report was due to be filed between January 1, 2000 and May 1, 2000, not January 1, 1999 and May 1, 1999. Its officers misunderstood your office's instructions, which state "a corporation annual report will be due this office between January 1 and May 1 of the year following the calendar year of the file date year." It was this corporation's belief that the "year following the calendar year of the file date year" was the end of 1999 since the file date was 1998. Therefore, it was believed that an annual report was due January 1, 2000. In addition, this corporation never received the notices advising that the report was due. If this corporation had received said notices it would have immediately filed its annual report. This corporation apologizes for the misunderstanding and unequivocally states that any failure to file its annual report was not intentional or to avoid its responsibility as a Florida corporation, but due to a misunderstanding of the language provided in the administrative rules.

This corporation is desirous of remaining in existence to conduct business in the State of Florida and will take all steps necessary to do so. It must be further stated that
