

The undersigned, acting as Incorporator of DIVINE DESTINATION, INC., a corporation organized under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:


1. **NAME.** The name of the corporation shall be DIVINE DESTINATION, INC.
2. **PRINCIPAL OFFICE/MAILING ADDRESS.** The principal office and mailing address of the corporation is 1221 5th Avenue South, Naples, FL 34102.


