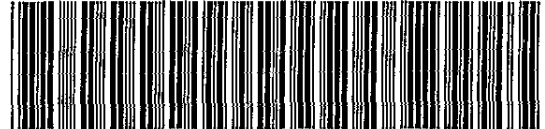

4. Article six (6) of the Articles of Incorporation of the Corporation is hereby amended to add the following director and to change the addresses of the Directors as follows:

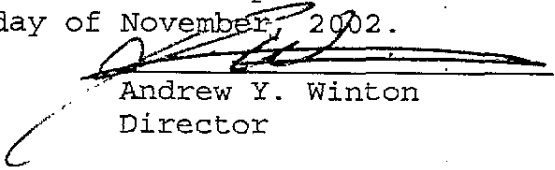
