

The undersigned incorporators hereby associate themselves together to form a corporation under Chapter 607, Florida Statutes.

ARTICLE I  
NAME

The name of the corporation is J.P. PROFESSIONAL SERVICES, INC. and its principal place of business is 206 North 3rd Street, Leesburg, Florida, with a mailing address of Post Office Box 594, Fruitland Park, FL 34731-9998.

ARTICLE II  
GENERAL PURPOSE

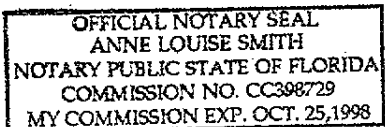

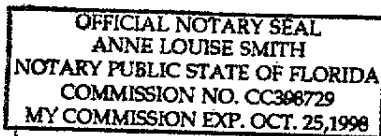
