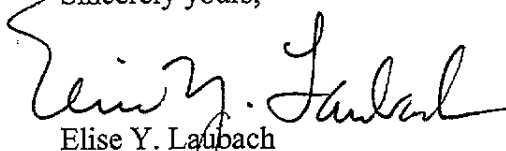

ARTICLES OF INCORPORATION

The undersigned incorporator delivers these Articles of Incorporation in order to form a corporation under the Florida Business Corporation Act.

**ARTICLE I**

**Name**

The name of the Corporation shall be TWK SKY, INC.

**ARTICLE II**

**Principal Office**

The principal office of the Corporation is located at 1312 Country Lane, Orlando, Florida 32804; the mailing address of the Corporation is Post Office Box 2501, Orlando, Florida 32801.

**ARTICLE III**

**Corporate Purposes, Power and Rights**

The purpose of the Corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV**

**Duration of the Corporation**

Existence of the Corporation shall commence on the 16th day of January, 1998, provided that all fees are paid and these Articles of Incorporation are filed by the Secretary of State within five (5) business days thereafter; the Corporation shall exist perpetually unless dissolved according to law.

**ARTICLE V**

**Authorized Stock**

The total number of shares of capital stock which the Corporation has the authority to issue is 10,000 shares of Common Stock, with a \$1.00 par value per share.

**ARTICLE VI**

**Registered Office and Registered Agent**

The street address of the initial registered office of the Corporation in the State of Florida shall be 1312 Country Lane, Orlando, Florida 32804. The name of the initial registered agent of the Corporation at the registered office shall be JOHN L. WEBB.

**ARTICLE VII**  
**Initial Board of Directors**

The initial Board of Directors shall consist of three persons. The names and addresses of the persons who shall serve as directors of the Corporation until the first meeting of shareholders are:
