ARTICLES OF INCORPORATION OF

CELTIC TRIBE INC.



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

- ARTICLE 1. Name. The name of the Corporation is: CELTIC TRIBE INC.


