**ARTICLES OF INCORPORATION**  
**OF**  
**AMERICAN MANUFACTURING INCORPORATED**

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. The name of the corporation is American Manufacturing Incorporated, 1572 Owen Drive, Clearwater, Florida 33759-2203.
2. The period of its duration is perpetual.
3. The purpose is to engage in activities or business permitted under the laws of the State of Florida and of the United States including, without limitation, the manufacturing and marketing of various products, and conduct its business, carry on its operations, and have offices and exercise the powers granted herein and by the Florida General Corporation Act within or without this State.
4. The corporation shall have authority to issue 1000 shares of common stock, \$ 1.00 par value per share. Ownership of the shares to be 500 for Gary A. Sharp and 500 for Gail L. Payne.
5. The address of its initial registered office is 1572 Owen Drive Clearwater, Florida 33759 and the name of its initial registered agent at said address is Gary A. Sharp.

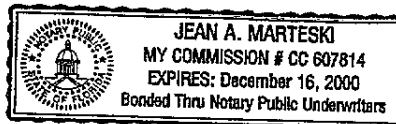
