ARTICLE 1- NAME

The name of this corporation is FIL A FIL SHIRTMAKERS, INC.

ARTICLE 2- PRINCIPAL OFFICE

ARTICLE 3- PURPOSE

ARTICLE 9- INDEMNIFICATION


The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.




