## **ARTICLES OF INCORPORATION**

Of

The undersigned subscriber (s) to these Articles of Incorporation, natural person (s) competent to contract, hereby form a corporation under the laws of the state of Florida.

### **ARTICLE 1- CORPORATE NAME**

The name of the corporation is: SUPRA BUSINESS SYSTEMS, INC.

### **ARTICLE II – DURATION**

This corporation shall exist perpetually unless dissolved according to Florida law.

### **ARTICLE III – PURPOSE**

This corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and the state of Florida.

### **ARTICLE IV – CAPITAL STOCK**

The corporation is authorized to issue Fifty thousand (50,000) shares at \$1.00 par value common stock, which shall be designated “common shares.”

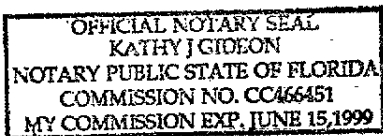
