

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation.

ARTICLE 1. NAME. SERVICES, INC.

The name of the corporation is: ABOVE ALL

11000, 1110.

ARTICLE 2. DURATION. The duration of the corporation is perpetual.


