CERTIFICATE OF INCORPORATION
OF

We, the undersigned, hereby associate ourselves together for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the State of Florida providing for the formation, liability, right, privileges and immunities of a nonprofit corporation.

ARTICLE I - NAME

The name of the corporation shall be:




