


ARTICLE IX - INDEMNIFICATION



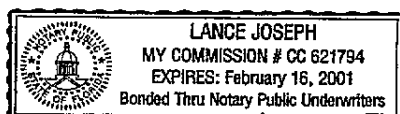
