ARTICLE VI - INITIAL DIRECTOR



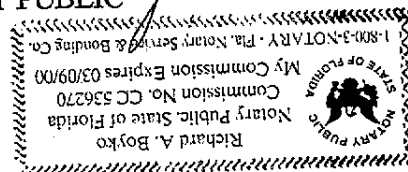


