- 1. The name of the corporation is JAZZ GREATS, COFFEE BLENDS, INC.
- 2. The duration of the corporation is perpetual.
- 3. The address of the registered office in the State of Florida is 4613 Imperial Palm Court, Largo, Florida-33771, County of Pinellas. The name of the Registered Agent at such address is Fenton E. Jones.
- 4. The purposes for which the Corporation is organized are:
- (a) To engage, without limitation, in any lawful activity for which corporations may be organized under the Laws of the State of Florida.
