ARTICLES OF INCORPORATION

OF

LOMA LINE, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of the corporation is:

LOMA LINE, INC.

ARTICLE II NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be:

- (a) To engage in the shipping and handling of ocean going freight.
- (b) To engage in any activities or business permitted under the laws of the United States and Florida.
- (c) To manufacture, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, and services of every class, kind and description.
- (d) To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks and licenses in the State of Florida, and in all other states, districts, territories, countries or colonies.
- (e) To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness, and execute such mortgages, transfer of corporate property or other instruments to secure the payment of corporate indebtedness, as required.
- (f) To purchase the corporate assets of any other corporation and engage in the same or other character of business.
- (g) To acquire by purchase, subscription or otherwise, and to receive, hold, own, guarantee, sell, assign, exchange, underwrite, transfer, mortgage, pledge or otherwise dispose of or deal in and
