The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida General Corporation Act.

ARTICLE I - NAME

The name of this corporation is **SUPERIOR INTERNATIONAL AGENCY, INC.**

ARTICLE II - DURATION

The corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

1. The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States and the State of Florida and for the transportation or services related for tourist or general public.
